PRIVACY POLICY

Gillingham Marina -General Data Protection Regulation (GDPR) & Privacy Policy

Your privacy is important to us, and we take the responsibility of handling your personal information very seriously. Our Privacy Policy describes in detail how we collect and handle your personal information, who we exchange your information with, how you can access and correct your information and how you can make privacy complaints.

Statement of Confinement

Collecting Personal Information

Using and Disclosing Your Personal Information

Personal Information will be used for the following primary purpose:

• To fulfil obligations pursuant to a client's request for, and Gillingham Marina Limited 's agreement to provide, services, products and/or any other agreement between him/her and Gillingham Marina Limited / to render services to the client / to provide information about products, services and/or special offers / to obtain opinions or comments about products and/or services from members.

Gillingham Marina Limited recognise the trust with which individuals provide personal information, and such information will not be used or disclosed for any other purposes without consent, except in exceptional cases when disclosure may be required by law or is necessary to protect the rights or property of Gillingham Marina Limited, any Gillingham Marina Limited group company, or any member of the public, or to lessen a serious threat to a person's health or safety.

Contact by Gillingham Marina Ltd

Gillingham Marina Limited does not send advertising information without obtaining prior consent. If an individual receives communications from Gillingham Marina Limited which they do not wish to receive, they may remove their name from the marketing database by contacting Gillingham Marina Limited via the contact page on the website, directly via email or telephone communication.

Individuals' Right of Access

Individuals have the right to review personal and/or sensitive Information that may be recorded on the Gillingham Marina Limited database. Information may be reviewed by submitting a written request.

A request may be made to delete or amend personal and/or sensitive information, and all reasonable steps to delete the information will be made, except where it is required for legal reasons. Deletion or amendment of information may result in Gillingham Marina Limited being unable to sell products directly and/or provide certain services including after sales services.

Storage and Security of Personal and or Sensitive Information

Gillingham Marina Limited takes all reasonable steps to keep secure personal information recorded and to keep this information accurate and up to date. The personal information is stored on secure servers if in digital format, or in locked areas if in hardcopy format: these are protected in controlled facilities. Gillingham Marina Limited employees and data processors are obliged to respect the confidentiality of any personal and/or sensitive information held by Gillingham Marina Ltd.

Gillingham Marina Limited only permits authorised personnel to access your information and information will only be disclosed to third parties where they have the appropriate authority. We destroy or de-identify personal information we no longer need, or we are no longer required by law to keep, wherever possible.
