### **NOTES:**

All berthing fees above rates are payable in advance. 12 month licence may be paid by quarterly Standing Order : Schedule Rate + 5%.

Berthing fees are based on LENGTH OVERALL including bowsprits, pulpits, davits, anchors, stern drives, etc. are rounded up to the nearest 0.2m.

The minimum chargeable length is 6.0m.

Berthing Fees include; supply of tap water, the use of deep moorings of periods up to 24 hours (to accommodate the tide, subject to reservation), car parking for up to 2 cars per craft, tender storage 1 per craft, 24 hour use of washrooms, showers and toilets.

**Refund of fees will only be made in accordance with general condition 10.1, which requires 16 weeks written notice to be given by the owner. Sub-letting of berth or storage is not permitted.**

**HARDSTANDING:** Hard standing may be available for licence holders, space permitting plus handling fees. The owner will be charged at an additional weekly rate (to the berthing contract) as stated in the schedule of charges.
